## **HOT WORK AUTHORISATION**

Following an audit of Poole Harbour Commissioners Safety Management System, it has become necessary to review the procedure for Hot Work Authorisation.

The new procedure applies to burning, welding or other work involving naked flames on board vessels berthed at any of Poole Harbour Commissioners commercial berths. ie Ballast, Bulwark, New Quay including the Extension, RoRo's 2 and 3, the Town Quay and the Fish Landing Area.

A completed **Hot Work Authorisation Request** form must be received by Poole Harbour Control prior to hot work commencing. The request will be approved, or not, and returned to the sender by the same medium it was received.

Attached is the latest version (4.0) of the form.

Mariners are reminded that Radar, AIS, CCTV, telephone and VHF channels are recorded.
